V. DISCUSSION/DECISION ITEMS

A. <u>Review Draft of Volunteer and Employee Background Check Policy</u>-*Ms. Beth reviewed revisions that were made to the existing School Volunteers Policy 353.1 as a result of the discussion that took place at the previous policy committee meeting. She also reviewed changes that were made to the existing volunteer application form (353.1 Exhibit). Specifically, a line for social security number was added because the information is required in order to conduct a national criminal background check.*

Ms. Beth also reviewed drafts of policies 533.1 on Pre-Employment Background Checks, and 541.1 on Intermittent Criminal Background Checks for Non-Licensed Employees. She will consult with legal counsel regarding policy 541.1 to determine if there is any duty to bargain over the implementation of this policy.

There was a motion by Mr. Hansen, seconded by Ms. Homan, to forward Policy 353.1 (School Volunteers) and Exhibit 353.1 (Application Form) to the full BOE for a second reading. Motion carried (3-0). There was a motion by Ms. Hill-Breunig, seconded by Mr. Hansen, to take drafts 533.1 (Pre-Employment Background Checks), and 541.1 (Intermittent Criminal Background Checks for Non-Licensed Employees) to the full board for a first reading. Motion carried (3-0). **B.** <u>Review Advertising Policy Regarding Concessions/ Proposal for</u> <u>Popcorn/Bags</u>

Mr. Smith discussed a proposal made by Hellenbrand Water, to purchase all popcorn, oil, and bags used by the district for concessions in exchange for being able to put their name on the popcorn bags. The committee discussed how this proposal fits with policy 851 (Advertising in the Schools). There was a motion by Ms. Hill-Breunig, seconded by Mr. Hansen, to inform the full board of their discussion and decision to approve the proposal, on an interim basis, for one year. Motion carried (3-0).
