President Meese called the district budget hearing and annual meeting to order at 7:00 p.m.

President Meese asked for nominations for the selection of a chairperson to conduct the budget hearing and the annual meeting.

Motion by Knutson/Hansen to nominate Paul Meese to serve as chairperson for the meeting.

Paul Meese was elected chairperson of the 2010 Annual Meeting unanimously on a voice vote.

Clerk Tryg Knutson read the official notice of the budget hearing and the annual meeting and noted its publication dates in the Waunakee Tribune.

Business Manager Steve Summers reviewed the Annual Meeting Report (Budget) and answered questions from the public.

Resolution G / Temporary Loan Authorization

Stats. for the purpose of meeting the immediate expenses of maintaining the schools of the district. Be it further resolved the amount of such temporary loan shall not exceed a sum of \$5,000,000.

Resolution I / Adoption of Levy Tax

Be it resolved that there be levied a school tax assessed against all taxable property within the Waunakee Community School District in the sum of \$23,338,494 necessary to operate and maintain the District School System and to finance the recommended budget for the 2010-2011 school year.
